## LAST CHANCE FOR ONLINE REGISTRATION FOR SPECIAL SPOT OFFLINE ROUND OF COUNSELLING FOR ADMISSION TO VARIOUS PROGRAMMES FOR ACADEMIC SESSION: 2022-23

This is for information of all the stakeholders that the University is in the process of commencement of **Online Registration for SPECIAL SPOT OFFLINE ROUND OF COUNSELLING for Admission in following Programmes** to be conducted in the University Campus, Dwarka for the Academic Session 2022-23. ### IMPORTANT INSTRUCTIONS:

#### 1. Category of candidates eligible to participate in Special Spot Offline Round of Counselling:

- (a) The University plans to conduct Special Spot Offline Round of Counselling for CET/NLT qualified candidates except the candidates as mentioned below:
- ADMITTED CANDIDATES** in respective programme for which they have qualified University CET/National Level Test, which will also include admitted candidates during Special Round of Offline Counselling in various programmes.
  - Candidates whose name exists in the list as **allotted candidates** during Second Spot Online Counselling.

2. The Candidates whose name exists in the allotted college portal as reported candidate is ADMITTED CANDIDATES are not eligible to participate in this Special Spot Offline Round of Counselling. The definition of ADMITTED CANDIDATES is given in the Admission Brochure.
3. The candidates who have participated in Second Round of Online Spot Counselling and have been allotted seat during 2<sup>nd</sup> Round of Online spot Counselling are **allotted candidates** and shall not be eligible to participate in this Special Spot Offline Round of Counselling

**NOTE:**

- (i) The allotted candidates who have been allotted seats in the sixth round of online counselling (Second Spot Counselling) but have for certain reasons missed the schedule date to report in the respective college will be considered by the University for the purpose of permitting of late reporting in the allotted college subject to availability of vacancy as on date and allotted candidate meeting the eligibility criteria. The said allotted candidates if wish to now report in the allotted college may kindly instructions below as in this notice.
- (ii) The candidates who wish to report in respective college allotted to him/her in the sixth round of online counselling (Second Spot Counselling) **must submit their application alongwith Demand Draft of Rs. 40,000/- or 45,000/- (if upgraded) in favour of Registrar, Guru Gobind Singh Indraprastha University to Admissions Branch, GGSIP University latest by 23.12.2022 (upto 04:00 P.M)** but application will be subject to availability of vacancy as on date and meeting eligibility criteria.

**No request of the allotted candidates will be entertained by the University for reporting in respective college allotted in the sixth round of online counselling (Second Spot Counselling) after 23.12.2022.**

4. It is once again clarified that the Special Spot Offline Round of Counselling is being held only for the candidates as defined in Para 1(a) above.
5. The candidates who have already taken admission in the Management Quota in affiliated colleges shall not be considered for participation in this Special Spot Offline Round of Counselling. It is further reiterated that in case any candidate who has taken admission in the Management Quota in any affiliated college/Institute, registers in the Special Spot Offline Round of Counselling shall not be allowed to participate in the Special Spot Offline Round of Counselling.
6. **Note: The candidate will be required to give an undertaking to the effect that he is neither taken admission in the Management Quota and nor he/she is ineligible for participating in this Special Spot Offline Round of Counselling as per the instructions in the Notice. The candidate will be required to give the undertaking in the format which will be provided at the time of counselling.**
7. Merely registration and participation by NLT/CET qualified candidates in Special Spot Offline Round of Counselling does not guarantee an admission to the such candidate in his / her choice of College or Stream as the allotment shall be purely on centralized merit basis of complete counselling held so far and in accordance with the CUT OFF rank determined through Online Counselling for the respective programme of respective college to ensure NO rank violation with respect to admitted candidates.

8. The conduct of Special Spot Offline Round of Counselling is with the purpose to only facilitate those candidates who for certain reasons have not able to get admission in the Online Counselling Process held so far. During the Special Spot Offline Round of Counselling, the University shall ensure that allotment of seat in respective programme in a college is purely on merit basis and in accordance with the CUT OFF rank determined through Online Counselling for the respective programme of respective college to ensure NO rank violation with respect to admitted candidates. The Hon'ble High Court of Delhi in a Writ Petition has upheld the policy of the University for NO Rank violation with respect to the admitted candidates.
9. For participation in this Special Spot Offline Round of Counselling, it is mandatory for each eligible Candidate to register through ONLINE portal by paying participation fee of Rs. 2500/- (non-refundable). Online Registration for Special Spot Offline Round of Counselling commencing from 23.12.2022 on [www.ipu.admissions.nic.in](http://www.ipu.admissions.nic.in) as per details mentioned as below:

For applicants who have qualified University CET/National Level Test :



2.	Candidates who have not filled online Application form earlier and now wish to participate for Special Spot Offline Round of Counselling.	Such candidates are required to register and pay the application fee of Rs. 1200/- (Non-Refundable) and Rs. 2500/- (Non-Refundable) through Net Banking/Credit Card and Debit Card towards Participation in Special Spot Offline Round of Counselling.	23.12.2022 (From 12:15 P.M Onwards)	25.12.2022 (upto 11:00 A.M)

10. Seats shall be allocated on the basis of all India basis purely on CET Rank/National Level Test Rank irrespective of Region and category subject to availability of seats.
11. The candidate will not be allowed for any kind of refund of fee after taking admission in Special Spot Offline Round of Counselling for Academic Session 2022-23.
12. The candidates are required to kindly go through the eligibility criteria as laid down in the Admission Brochure for Admission to various courses as mentioned above for the Academic Session 2022-23 available on the University Website [www.ipu.ac.in](http://www.ipu.ac.in) and [www.ipu.admissions.nic.in](http://www.ipu.admissions.nic.in).
13. Further Schedule of Special Spot Offline Round of Counselling shall be notified on 26.12.2022.

14. Tentatively Special Spot Offline Round of Counselling will be held on 27.12.2022, 28.12.2022, 29.12.2022 and applicants will be required to bring Demand Draft of Rs. 1,00,000/- (Rs. One Lakh Only) in favour of Registrar, Guru Gobind Singh Indraprastha University as per the schedule to be notified on 26.12.2022. The University will not entertain any request of a candidate for not been able to bring demand draft as stated above and the University shall allot the seat to the next candidate present at the time of Special Spot Offline Round of counselling.

15. This is the last opportunity for CET/NLT qualified candidates who have not taken admission in any programme so far or have not been allotted seats in the last Spot Round and Special Round of Offline Counselling for admission through Special Spot Offline Round of Counselling against vacant seats wherever existing.
